

To: Students in isolation or quarantine

Re: Reimbursement for quarantine/isolation costs
Date: Fall and Spring semesters 2020-2021

As you have heard from your case manager, there is no out-of-pocket expense for your stay in Purdue quarantine and isolation housing. You will receive an invoice from Aramark at the end of your stay, and Purdue will provide assistance in obtaining a reimbursement to cover the cost. **You are not required to pay your Aramark bill until you receive reimbursement.**

CARES Act funds (U.S. citizen students) or Protect Purdue funds (Non-U.S. citizen students) will cover the cost of your stay at Purdue Village. To obtain reimbursement after receiving the Aramark invoice, please follow the process below.

U.S. CITIZEN STUDENTS ELIGIBLE FOR CARES ACT FUNDS FOR REIMBURSEMENT

If you live in University Residences:

- You will receive a bill for **\$335** from Aramark for isolation/quarantine housing.
- Apply for CARES Act funds following the instructions from the Division of Financial Aid: www.purdue.edu/dfa/.
 - **You do not have to pay your Aramark bill until you receive these funds.**

If you live off-campus:

- You will receive a bill from Aramark for isolation/quarantine housing based on the duration of your stay.
 - If you stay 1-5 days, your bill will be **\$445**.
 - If you stay 6-10 days, your bill will be **\$555**.
 - If you stay 11-15 days, your bill will be **\$665**.
- Apply for CARES Act funds following the instructions from the Division of Financial Aid: www.purdue.edu/dfa/.
 - **You do not have to pay your Aramark bill until you receive these funds.**

NON-U.S. STUDENTS ELIGIBLE FOR PROTECT PURDUE FUNDS FOR REIMBURSEMENT

For students in Purdue isolation/quarantine housing:

If you live in University Residences:

- You will receive a bill for **\$335** from Aramark for isolation/quarantine housing.
- Please contact Julie Cox, Associate Dean of Students, to request Protect Purdue funds to pay your bill: jtalz@purdue.edu or 765-494-1747.
- The Protect Purdue funds you receive should be used to pay your Aramark bill.
 - **You do not have to pay your Aramark bill until you receive these funds.**

If you live off-campus:

- You will receive a bill from Aramark for isolation/quarantine housing based on the duration of your stay.
 - If you stay 1-5 days, your bill will be **\$445**.
 - If you stay 6-10 days, your bill will be **\$555**.
 - If you stay 11-15 days, your bill will be **\$665**.

Between December 28, 2020 and January 10, 2021, Students returning to campus from outside the US must self-quarantine for 14 days. If students choose to reserve space on campus at designated quarantine space, charges will be covered, following the process outlined above. If students choose to self-quarantine away from campus, receipts for lodging and meals may be submitted for reimbursement:

- Purdue will cover the following quarantine-related expenses:
 - Up to **\$335** total for housing/lodging.
 - Up to **\$22** per day for meals.
 - Not more than **\$665** total.
